Operations-

All Crest Memorial School District students are eligible to attend CAP. All children must adhere to the district's policies and procedures, including Code of Conduct.

Times:

School days - morning drop off **7:00am** at cafeteria (Pacific Ave lot/basketball courts)

Cost:

7am-8am= \$6 per day + breakfast cost \$1 or free/reduced fee)

3pm-4pm= \$6 per day prompt pick up is required or you will be charged the 5pm rate

3pm-5pm= \$12 per day

Morning-after combo till 4:00=\$10

Morning-after combo till 5:00=\$15

2nd child 20% discount, 3rd child 50% discount

Early dismissal school days=additional \$12

10% discount for scheduling and paying prior to the beginning of the month
